

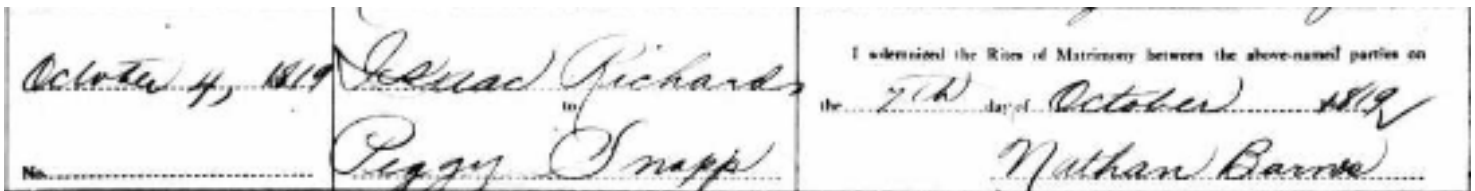

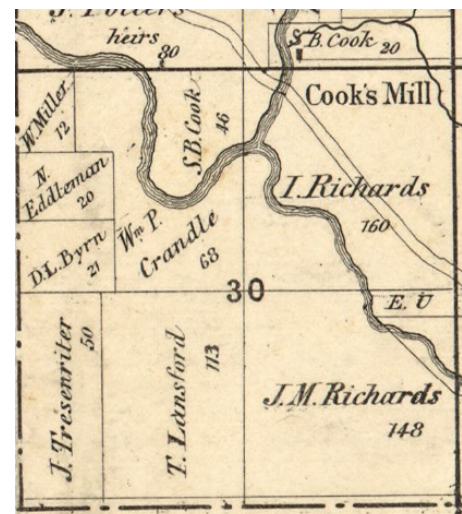

The Richards were famers. It is likely they were land owners and not tenant farmers, but unable to find land records.

The 1859 map shows I. Richards, and J. M. Richards holding the two quarter sections south of Cook's Mill. These quarter sections were held in 1820 by George Capilly and Magdalene Baker respectively.

An 1882 map shows the upper section still in the Richards family.

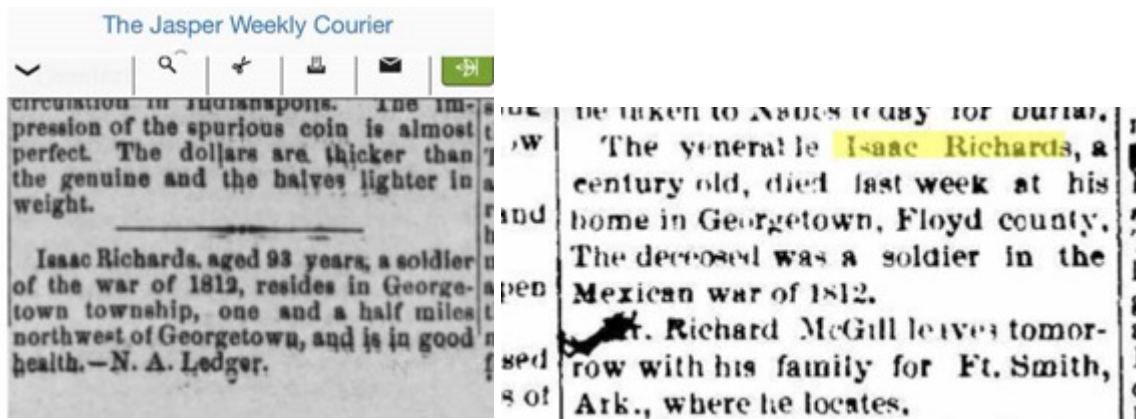

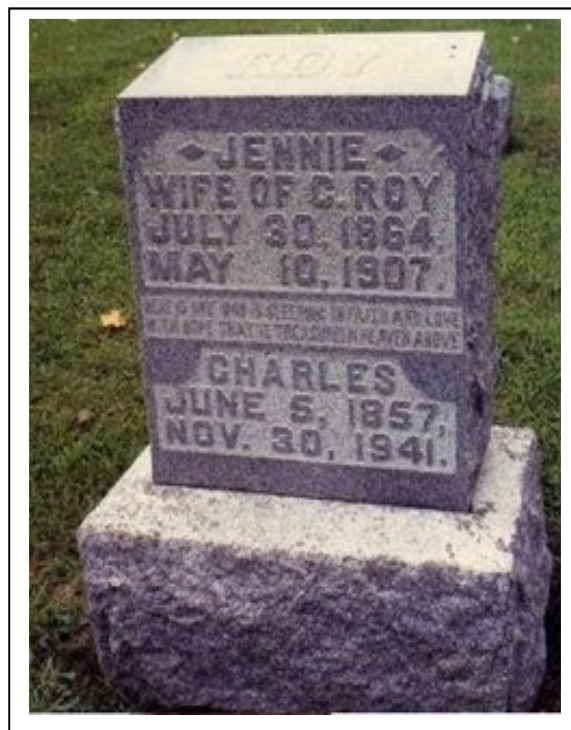
